## **Biographical Note**

Hal Karl Rothman was born on August 11, 1958 in Baton Rouge, Louisiana. In 1980, Rothman was awarded a B.A. from the University of Illinois at Urbana-Champaign, an M.A. in 1982 from the University of Texas at Austin, and a Ph.D of History in 1985, also at the University of Texas

at Austin. After five years of lecturing at Wichita State University in Wichita, Kansas, Rothman relocated to Las Vegas, Nevada to establish a Ph.D program in western history at the University of Nevada, Las Vegas (UNLV). Rothman became the history department chair in 2002 and held the position until 2005. In 2006, Hal was named a distinguished professor by then-UNLV president Carol C. Harter. In December 2005, Hal was diagnosed with ALS (Lou Gehrig's disease) and passed away on February 25, 2007 at the age of 48. As of 2020, the American Society for Environmental History holds the Hal Rothman Dissertation fellowship for Ph.D students in the field of environmental history in honor of Rothman's distinguished service to the society.
