She worked with Mark Fine of American Nevada's Green Valley development; Pacific International Realty; Rancho Vista Realty; and her own company, Wilner Associates, which later joined Realty 500 Reiss Corporation Management. Her uncle, Leo Wilner, was Executive Director of Temple Beth Sholom from 1966 to 1984.
